Workshop Summary

This ethics workshop will address ethical decision-making, the relationship between ethics and law with specific attention to Alaska state law, and ways to minimize exposure to legal and ethical liability. This workshop will include a discussion of the APA Ethics Code, with a focus on the structure of the Code and specific ethical standards that are especially relevant to ethical practice. The program will emphasize how psychologists can use the APA Ethics Code to facilitate ethical decision-making. Case vignettes will be used to illustrate ethical decision-making applied in actual clinical practice.

Learning Goals and Objectives

- 1) Identify a process for resolving legal and ethical dilemmas;
- 2) Find concrete ways to minimize exposure to legal and ethical liability;
- 3) Use the Ethics Code as a tool to facilitate ethical decision-making;
- 4) Understand how specific standards in the new Ethics Code relate to the practice of psychology.
